### MSP Carpark expansion works

Works to expand the Mildura Sporting Precinct carpark are currently underway.

### 2024 Mildura Planning Scheme Review

Round 1 Community Engagement Council has appointed a consultant team led by Plan2Place to undertake the 2024 Mildura Planning Scheme Review.

The Mildura Planning Scheme is a statutory document that controls how land is used and developed within the Mildura municipality. It also helps preserve the things we love about our region. A planning scheme review is a requirement of the Planning and Environment Act 1987 and is to be undertaken by Council every four years.

The aim of the review is to assess how the Mildura Planning Scheme is performing and outline a plan to implement changes to respond to identified gaps. This will ensure the planning scheme remains up to date and responsive to changing circumstances, including shifts in government policy, community aspirations, and land use issues and trends.

Plan2Place and Council officers will be conducting in-person community consultation on the following dates:



The amendment has been prepared by Mildura Rural City Council, which is the planning authority for this amendment.

The amendment has been made at the request of the landowner.

The amendment applies to land at 13 Dal Farra Road, Irymple, being Lot 1 TP674265 and Lot 1 TP232429.
