The Internal Audit and Risk Committee reports to Council and provides advice and recommendations on matters relevant to its Charter to facilitate decision-making by Council and assist in the effective conduct of its responsibilities for financial reporting, management of risk, internal controls and ethical development.

The Committee pursues Better Practice Guidelines for Audit and Risk Committees and internal audit. Council is committed to establishing and supporting the primary objectives of the Committee. The Committee meets bi-monthly and all members are required to sign a Confidentiality Agreement. Remuneration, set by Council, is paid to all Audit and Risk Committee members.

Review of the Revenue and Rating Plan

Mildura Rural City Council is undertaking a review of its Revenue and Rating Plan and is seeking feedback from the community.

Council must review its Revenue and Rating Plan in accordance with the Local Government Act 2020. The Revenue and Rating Plan must be reviewed by the elected Council following local government elections (every four years).

The Mildura Rating and Revenue Plan sets out the system of rates and charges adopted by Council for the purposes of distributing the rates burden across the municipality on a fair and equitable basis.

AEC Group has been engaged to assess Council's current rates climate, with their report, which is available to the public, investigating four scenarios.

The report recommends scenario two as the preferred model, which proposes the following differential rates for the next four years:

- Residential: 100% (no change from previous plan)
- Farming: 90% (no change from previous plan)
- Business: 140% (a 10 percent increase from the previous plan)

The amendment has been prepared by Mildura Rural City Council, which is the Planning Authority for this amendment. The amendment has been made at the request of the landowner. The amendment applies to land at 174 Cootamundra Avenue Red Cliffs.

The amendment proposes to:

- Rezone the land from the Public Conservation and Resource Zone (PCRZ) to Farming Zone (FZ).

Any person may make a submission to the planning authority about the amendment. Submissions must be made in writing giving the submitter's name and contact address, clearly stating the grounds on which the amendment is supported or opposed and indicating what changes (if any) the submitter wishes to make.

Name and contact details of submitters are required for the planning authority to consider submissions and to notify such persons of the opportunity to attend planning authority meetings and any public hearing held to consider submissions.

The closing date for submissions is Monday 14 April 2025. A submission must be sent to Manager Strategic Planning, MRCC, PO Box 105, Mildura, VIC, 3502 or strategic.planning@mildura.vic.gov.au.

The planning authority must make a copy of every submission available at its office and/or its website for any person to inspect free of charge until the end of the two months after the amendment comes into operation or lapses.
