#### Review of the Revenue and Rating Plan

Mildura Rural City Council is undertaking a review of its Revenue and Rating Plan and is seeking feedback from the community.

The Mildura Rating and Revenue Plan sets out the system of rates and charges adopted by Council for the purposes of distributing the rates burden across the municipality on a fair and equitable basis.

AEC Group has been engaged to assess Council's current rates climate, with their report, which is available to the public, investigating four scenarios. The report recommends scenario two as the preferred model, which proposes the following

- differential rates for the next four years: Residential: 100% (no change from
- Farming: 90% (no change from previous
- Business: 140% (a 10 percent increase from the previous plan)
