#### **Quick Checklist about your home**

There is no need for all your home to be accessible for Family Day Care to run your business from home. Your family needs to have their own spaces for their belongings and privacy. Children need to have enough space to play and rest and have access to a bathroom and toilet. You are required to have a space to store and prepare food safely. Please see link to Family Day Care Guidelines for the Educator and their family.

Some things to consider before you get started:

- Fencing- to be unscalable and high enough to be safe.
- Glass- any glass under 0.75cm needs to be safety glass or filmed, all door glass in or around the door is to be all safety glass or filmed.
- General safety- power point covers, hot water max 50°, window blind cords are to be anchored or out of reach, stove tops knobs inaccessible.
- Swimming pools to be compliant through Council.
- Water hazards made safe i.e. ponds with wire grate over the top.
- Pets can they be made inaccessible to children, have their own space.

#### Applying for a position as a Family Day Care Educator

This guide has been designed to help you understand our recruitment process and to provide you with some tips and ideas for ensuring that your application and your interview are high quality and relevant.

#### What are the Selection Processes

Estimated timelines for the steps in our recruitment process are:

- Return Family Day Care Educator Application 2 weeks from when you were sent the application.
- Letter of Acknowledgement sent within 1 week from receiving your application
- Interview 1 to 2 weeks from receiving your application

Referee Checks – within 1 week from completion of your interview

Total of approximately 6 weeks

#### How do I Apply

The primary function of an application is to provide sufficient information about your education, work history and experiences to allow the Family Day Care Support Team to decide whether you should be interviewed for the position.

Applicants should prepare the following information:

- 1. A letter of application
- 2. A current resume
- 3. A completed Family Day Care Application Questionnaire
- 4. A completed Prospective Educator Information Form
- 5. A Doctor's Certificate stating that they are fit and able to perform the duties of a Family Day Care educator
- 6. Written Landlord permission if renting

IMPORTANT: Employment as a Family Day Care Educator will be subject to the Recruitment and Selection Policy and Procedure. Mildura Rural City Council Family Day Care is committed to Child Safety and is a Child Safety organisation. As such, applicants will be required to hold a current Working with Children Check for the state they reside and a have a successful Police Check that is valid (within 6 or 3 months according to the type of check) before starting.

#### What happens Next??

#### The Interview

An interview is the key part of the selection process and can be thought of as an "information gathering exercise" as it provides the Family Day Care Support Team the opportunity to gather specific information about an applicant.

- You will be contacted by telephone if you have been selected for an interview
- You will be provided with details regarding the time, day and location of the interview
- The interview panel will usually consist of two panel members
- During the interview panel members will ask questions to determine if you are suitable for the position
- You will have an opportunity in the interview to ask questions
- If you have not provided referee details on your resume, be prepared to provide at least 2 referees at the interview
- Referee checks will be conducted at the conclusion of the interview

 Please contact the Family Day Care Support Team if you are running late, cannot attend the interview or wish to withdraw from the process

If you are unsuccessful in obtaining an interview, you will be notified in writing.

#### After the Interview

If you have been successful:

- You will be notified by telephone
- An agreed date will be decided for you to attend the Family Day Care Orientation Training Session

If you have been unsuccessful:

- You will be notified by telephone of the interview panel decision, followed by a letter confirming the outcome
- You are able to contact the Family Day Care Support Team for feedback on your application and interview

#### What support will you receive?

Our experienced, qualified, professional staff in the Family Day Care Support Team is there to support you by:

- Regular visits to your home to provide support and advice.
- 24-hour phone support. Out of hours for emergencies only
- Training opportunities and advice and assistance on further education
- · Support to help you grow your business
- Fortnightly parent CCS payments
- Training and support on collecting and managing your fees

#### How many children can you care for?

Registered Educators can care for a maximum of 4 pre-schoolers at any one time - this includes any pre-schoolers of your own. Educators can care for up to 7 children (i.e. school age + preschool)

#### What will you earn as an Educator?

As a registered Educator you operate as a self-employed, small business contractor. Registered Educators are not employees of Mildura Rural City Council.

You will set your own fees in conjunction with the services fee guidelines and charges. You need to reach a business decision to determine the fee you are going to charge for the childcare and education program you provide. When determining your standard fee, it is important to assess your expenditure and income requirements. To do this you can draft a budget which outlines what you expect to spend (projected expenditure) and what you need/want to earn (income) over a set period of time.

The placement of children with an Educator depends on many variables, including the area in which you live, your location in relation to public transport, how many pre-school children you have of your own, whether you transport your own children to and from school, etc. Children come in and go out of care all the time and when a child leaves your care there is no guarantee that another child will be placed with you immediately.

On average, an Educator caring for 4 pre-school children can expect to earn approximately \$400 per day before tax. Educators must ensure that they keep accurate records for taxation purposes as Council does not deduct tax. All Educators must hold a current Australian Business Number (ABN) available online from the Australian Business Register <a href="https://abr.gov.au">https://abr.gov.au</a>

#### Insurance

Educators are responsible for maintaining all insurances required, including Public Liability insurance for at least \$10,000,000.
