

#### 1. The purpose of this policy is

To state Council's approach to the management of native vegetation on Council managed land.

#### 2. Policy Statement

Mildura Rural City Council is responsible for the management of native vegetation on both freehold land and land under Council's Committee of Management. This includes municipal roadsides, the Murray River Permanent Reserve and various other parcels. Council recognises the value of native vegetation in providing:

- · Wildlife corridors and habitat,
- · supporting ecosystems and biodiversity,
- amenity,
- · ecosystem services such as, windbreaks and soil conservation,
- · heritage value

Council is committed to protecting and managing native vegetation in accordance with State Government regulations.

#### 3. Principles

#### **Native Vegetation Management**

The protection of native vegetation on Council land is considered a high priority. Management actions in areas of native vegetation include but are not limited to:

- The prevention/closure of unauthorised tracks with fencing, bollards, logs etc.
- litter/illegal dumping collection
- revegetation with indigenous species

- mulching
- · pest plant and animal control
- strategic provision and maintenance of recreational areas/furniture (picnic tables, authorised tracks and parking areas) that are sensitive to the natural environment

Native vegetation impacts will be identified and considered in the planning stage of all projects, with the protection and avoidance of damage to native vegetation a priority. Employees with the potential to impact native vegetation will be appropriately trained in native vegetation management.

#### **Native Vegetation Clearing**

Any proposed native vegetation clearing on Council land, or unique use requests on Council land containing native vegetation must go through Council's Land Managers Consent process. The purpose of the clearing must be clearly conveyed including demonstrated avoidance in accordance with State Government regulations.

Illegal clearing on Council land will be managed in a consistent and transparent manner. A clear decision-making process will be followed for prosecution of illegal native vegetation clearing on Council land.

## 17.1 SPEED LIMIT TRIALS

File Number: 02/01/13

"I note in the draft minutes of the February meeting that Cr Milne states the speed limits in the trial zones have now changed permanently. I pose the following question in two parts. Part a). The 12 Month trial commenced on 28th April 2023. How is it that the speed limits have now changed permanently when the trial has not run its course?, further to this there has been no additional time for data analysis. Part b). On completion of the trial, will council now make public the data collected as a result of the trial. In particular the pre trial/post trial data comparison that prompted the permanent change."

General Manager Infrastructure & Assets advised that Councils in Victoria do not have the power to permanently change speed limits. This can only be done via State Government approval. There are only a number of situations where Councils have the power to change speed limits (on a temporary basis) which are;

- Roadworks
- Community events
- Roadside hazards

Therefore, in order for Council to undertake the 30km/h trial, this needed the approval of the State government to change the speed limit from 40 to 30.

It is also worth noting that at the time of seeking approval, there was no other 30km/h approved speed limits in the State. Therefore, the State Government was interested in seeking information on how this speed limit was going to perform and how it was viewed by the community. Hence the reason for the trial.

As part of the approved trial conditions, Council was required to collect data over a 12 month period and assess this at the end of the trial.

The assessment of the data will help determine whether the speed limit should be changed from 30 back to 40.

Once the Council has an opportunity to consider the data gathered as part of the trial, they can then consider whether there is justification to request the State Government to change the speed limit back to 40km/h.

Therefore the 30km/h limit will remain as a permanent speed limit until such time Council considers this report.

The second part of the questions asks whether this data will be made public. Yes, the data will form part of the report that will be presented to Council at a future Council meeting. This information will be part of the Council agenda (which will be available to the public). This is likely to come to Council in July / August 2024.
